4.2. Most important symptoms and effects, both acute and delayed

Symptoms/Injuries: May cause respiratory irritation. May cause cancer. Causes damage to organs through prolonged or repeated exposure. This product, if heated may release asphalt fumes. During processing, inhalation of fumes may cause dizziness and/or irritation to the eyes, nose, and throat. Hot molten product will cause thermal burns to the skin.

Symptoms/Injuries After Inhalation: Toxic fumes may be generated from heating asphalt and may be harmful if inhaled. Prolonged exposure may cause irritation. WARNING: irritating and toxic hydrogen sulfide gas may be present. Greater than 15-20ppm continuous exposure can cause mucous membrane and respiratory tract irritation. 50-500 ppm can cause headache, nausea, and dizziness. Continued exposure at these levels can lead to loss of reasoning and balance, difficulty in breathing, fluid in the lungs, and possible loss of consciousness. Greater than 500ppm can cause rapid unconsciousness and death if not promptly revived. For particulates and dust: Cough, dyspnea (breathing difficulty), wheezing; decreased pulmonary function, progressive respiratory symptoms (silicosis). Accelerated silicosis can occur with exposure to high concentrations of respirable crystalline silica over a relatively short period; the lung lesions can appear within five years of the initial exposure. The progression can be rapid. Accelerated silicosis is similar to chronic or ordinary silicosis, except that the lung lesions appear earlier and the progression is more rapid. Acute silicosis can occur with exposures to very high concentrations of respirable crystalline silica over a very short time period, sometimes as short as a few months. The symptoms of acute silicosis include progressive shortness of breath, fever, cough and weight loss. Acute silicosis can be fatal.

Chronic Symptoms: According to the International Agency for Research on Cancer (IARC), exposure to asphalt fumes may be carcinogenic to humans. For particulates and dust: Pre-existing lung diseases such as emphysema or asthma may be aggravated by exposure to dusts. Pulmonary function may be reduced by inhalation of respirable crystalline silica. Lung scarring produced by such inhalation may lead to a progressive massive fibrosis of the lung which may aggravate other pulmonary conditions and diseases and which increases susceptibility to pulmonary tuberculosis. Progressive massive fibrosis may be accompanied by right heart enlargement, heart failure, and pulmonary failure. Smoking aggravates the effects of exposure. Some studies show that exposure to respirable crystalline silica (without silicosis) or that the disease silicosis may be associated with the increased incidence of several autoimmune disorders such as scleroderma (thickening of the skin), systemic lupus erythematosus, rheumatoid arthritis and diseases affecting the kidneys. Some studies show an increased incidence of chronic kidney disease and end-stage renal disease in workers exposed to respirable crystalline silica. Repeated inhalation of respirable silica dust is associated with an increased incidence of cancer.

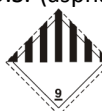
